### **Deliberations and Discussions taken:**

1. **Acceptance of Previous Meeting Minutes:**
  - The minutes of the previous meeting held on 10.09.2024 were reviewed and accepted unanimously by all members.
2. **Awareness Campaigns and Programs:**
  - The committee discussed plans to organize workshops and awareness drives for the upcoming semester to educate students about anti-ragging measures.
  - It was decided to host an interactive session led by senior students to promote peer support and inclusivity.
3. **Suggestions for Strengthening Anti-Ragging Policies:**
  - The committee proposed increased vigilance during college events and at hostels.
  - Members suggested enhancing online reporting mechanisms to ensure ease of reporting ragging incidents anonymously.
  - It was recommended to hold regular surprise inspections at high-risk areas such as hostels and common rooms.

  - The Chair approved a suggestion to include anti-ragging awareness in the annual orientation program for parents.
  - A decision was made to conduct a feedback survey among students to assess the effectiveness of current anti-ragging measures.


## Conclusion
